

Privacy Policy for Website Application

This privacy policy governs the use of the personal information you may provide when you download and/or register the Application www.texan-jeans.com. Registration with us is optional. However, do keep in mind that you may not be able to use some of the features offered by the Application unless you register with us. When you register with us and use the Application, you may provide some of the information below:

- 1) Your name, email address, age, user name, password and other registration information;

Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices' ID, the IP address of your mobile device, your device's operating system, the type of mobile Internet browsers used, and information about the way you use the Application.

Does the Application collect precise real time location information of the device?

When you visit the Application, we may use GPS technology (or other similar technology) to determine your current location in order to determine the city you are located within and display a location map with relevant advertisements. We will not share your current location with the public. If you do not want us to use your location for the purposes set forth above, you are advised to turn off the "location" of your mobile device which is located in your account settings or in your mobile phone settings and/or within the mobile application.

Do third parties see and/or have access to information obtained by the Application?

Yes. We will share your information with third parties only in the ways that are described in this privacy statement.

We may disclose User Provided and Automatically Collected Information:

- o if required by law, such as to comply with a subpoena, or similar legal process;
- o when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- o with our trusted services providers who work on our behalf but do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.

What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that have provided via the Application, please contact us at texanjeans@gmail.com and we will respond in a reasonable time. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Children

We do not use the Application to knowingly solicit data from or market to children under the age of 13. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at texanjeans@gmail.com. We will delete such information from our files within a reasonable time.

Security

We are concerned about safeguarding the confidentiality of your information. We practise physical and/or electronic procedure to safeguard and protect the information collected. For example, we limit the access of this information to authorized employees and contractors only who require the information to operate, develop or improve our Application. Please be aware that although we endeavour a reasonable security system to protect the information collected, no security system can prevent all potential security breaches.

If you reside outside Malaysia your information will be transferred, processed and stored there under Malaysia privacy standards.
